





Fall 2017 & Spring 2018 E-Learning Data

NTU acquired membership to the National Council for State Authorization Reciprocity Agreements (NC-SARA) on May 26, 2017. This membership allows NTU to deliver fully online courses anywhere without having to get state-by-state approval to deliver our online courses. Becoming members of NC-SARA will help with meeting HLC requirements as we move forward in offering fully online programs. Another fact is NTU is the first Tribal College and University to join SARA.


WE OFFERED 39 FULL ONLINE COURSES WITH 23 ONLINE FACULTY FOR THE FALL 2017 SEMESTER. THE ENROLLMENT FIGURES RANGE FROM 2 TO 29 STUDENTS IN THE COURSES. THE GRAPH BELOW SHOWS THE NUMBER OF ENROLLMENT AND THE COURSES OFFERED WITH TOTAL NUMBER BEING 369 STUDENTS.







IN COMPARING AND

THE PIE CHARTS SHOW THAT ONLINE COURSES HAVE A 65.31% PASS FINAL GRADES AND 71% PASS RATE WHEN CALCULATING A,B,C,D'S AND SEPARATING F AND W. USING THE FACULTY AND STUDENT E-LEARNING POLICIES AS A REFERENCE AND ENSURING THE E-LEARNING DEPARTMENT COMPLETES ITS EFFORTS TO PROVIDE AND DEVELOP ONLINE INTERACTIVE SUPPORT SERVICES FOR BOTH FACULTY AND STUDENTS COULD SERVE AS A MEANS TO INCREASE THE SUCCESS OF ONLINE LEARNING. 


















BELOW IS THE TOTAL NUMBER AND PERCENTAGE ACCORDING TO GENDER FOR ONLINE COURSES. THE TOTAL AMOUNT OF 279 REFERENCES ONLINE UNDUPLICATED STUDENT HEADCOUNT. (TOTAL ENROLLED/COURSE ONLINE STUDENT HEADCOUNT 369 - 90 DUPLICATED STUDENTS = 279 UNDUPLICATED ONLINE STUDENT HEADCOUNT) THE DATA NOTES THAT THE MAJORITY OF THE ONLINE STUDENTS ARE AMERICAN INDIAN, 69% ARE FEMALE, 35% ARE AGES 18-14 (97 STUDENTS) AND 38% ARE AGES 25-34 (105 STUDENTS).







TOTAL NUMBER OF MINORITY STUDENTS IN ONLINE COURSES FOR FALL 2017.






THE NEXT TWO GRAPHS INCLUDE SPRING 2017 - AGE OF ONLINE STUDENT AND PERCENTAGE.







